Freshfel Europe is the umbrella organisation for the fresh fruit & vegetable supply chain in Europe & beyond.

Founded in 2001, Freshfel Europe represents the whole fresh fruit & vegetable supply chain, including producers, traders, wholesalers, importers & exporters, logistics, service providers & retailers.

Freshfel Europe is the main sector representative body in EU decisionmaking. Freshfel Europe represents the common interests of the supply chain for the benefit of the fresh produce sector & consumers.

Freshfel Europe works closely with the European institutions in EU-level policy-making as well as with global organisations including FAO, WTO & UNECE on international issues.

Freshfel Europe is governed by a Board consisting of 25 full members. The Freshfel Europe Secretariat is based in Brussels, Belgium and is a non-profit association under Belgian Law registered in the EU Transparency Register.

#### Freshfel Europe's members

Freshfel Europe has 113 members based across Europe & globally. This excludes Freshfel Europe's members' branches, satellite and subsidiary companies.

Freshfel Europe members are leading EU & global fresh produce stakeholders with a drive to be at the forefront of the sector, including companies, interbranch organisations, national associations, sectorial & product organisations & service providers.

Freshfel Europe membership is divided into full members, including those stakeholders with direct activities with fresh produce, and associated members, including those stakeholders with indirect activities with fresh produce.

#### Freshfel Europe membership fees

Freshfel Europe membership fees are paid on an annual basis commencing from the date of joining.

Freshfel Europe membership is divided into 14 categories, categories A to N.

Membership category is allocated based on the applicant's:

- 1. Status as either a company or association;
- 2. Location in Europe or outside of Europe, and
- 3. Turnover.
